The Independent Investigative Mechanism for Myanmar (IIMM anihlole Mechanism) cu United Nations hnuiaia om Human Rights Council in kum 2018, September thlaa a din, finfiahna lakkhawm tu pawlte an ni. Mechanism chu inthliarhranna om miah lole thunun bik tu hnuiaia om loin zalen takin khawvel pumpui daan bawhchiaa sualna rapthlak tak sualrawngbawl tute en thlatu le finfiahna lakkhawm tu anni.

Kum 2011 atanga Burma ramchhung hmun hranghranga sual rawngbawlna om zawngzawng finfiah na lain khawlkhawm tu anni. Cumi khawlkhawm zingah chuan raldo na hmun leh ral indo laiin midang chung a nunrawngtaka sualna thlen nate, mipui tamtak chung a chiatna namenlo thlent, mipui leh pawl om hote ti cimih vek tumna te atel ani. Hetiang finfiahna khawlkhawm naah hian sual rawngbawl tuleh harsatna lo tuartu tehi eng chi leh hnam nge annih, eng ang pawl le mipui nen enganga in hnamhnoihna neinge anni tihhi Mechanism hian a en lo.
